Additional Information

Booths:

This is an outdoor event and the booth/canopy must be designed to withstand wind and inclement weather. Weights and sides are recommended. Electricity and water are not available; vendors must be self-contained. Set up time: Saturday morning October 4, 2008 from 7:00am to 9:00am. Event opens to the public at 10:00a.m.

Requirements and Restrictions:

1. Vendors will be staffing their own booth, collecting their own money and paying their own taxes. Sales tax is now at 8.5%
2. Vendors must obtain all state and local tax permit necessary for

your operation.

3. Vendors are responsible for cleaning up all litter from their space.
4. Vendors are not allowed to rove with their merchandise at any time.
5. No alcoholic beverages, smoking or excessive hawking will be allowed in the vicinity of your booth.
6. Vendor agrees that the management shall be held blameless and not financially liable for any personal injury to the exhibitor or his/her helper. Management is not liable for any merchandise or property stolen or damaged in any way. The vendor assumes all such responsibility.
7. Vendors selling specialty food items agree to package, sell and sample according to Washington State, county city and federal regulations. Vendor assumes all responsibilities.
8. All pertinent fire codes, laws, ordinances and regulations pertaining to health fire prevention and public safety shall be strictly obeyed.
